Notes on Validity of Nominations

During the time that nominations were open for this election, a candidate asked about the validity of a nomination endorsed by a Club Office-Bearer who ceases to hold office prior to the AGM. After seeking legal advice, it was ruled that a prior nomination need only be valid at the time of nominations closing. Chloe Driver ceased to hold the office of Secretary of the Monash Electronic Gaming Association on Wednesday 3 September, but did not have her nomination invalidated for this reason.
